


History

Membership Grades

- Student free

- Associate does not have formal qualifications
- Fellow after 15 years and contribution
- Registered Professional Geologist professional expertise reviewed by peers and continual development
- Retired if have been member for 10 years



Documentation Required

- Academic qualifications
- Proposer and seconder
- Relevant employment and experience
- Payment of fees
- Professional Registration for RPGeo is required



AIG Code of Ethics

- Principle -The <u>core responsibilities</u> of Professional <u>Institutes include:</u>
 - Promotion, continuous improvement and enforcement of standards of ethical and professional conduct; and,
 - Facilitating continued professional development (CPD) by members.
 - Act professionally and with fidelity to all
 - Careful in statements and assertions about facts and people
 - Responsible for subordinates and training



AIG Code of Ethics

- Establishes and maintains public confidence in the profession.
- Acceptance of an enforceable Code of Ethics by members distinguishes Professional Institutes from "Learned" Societies.
